OUR TRAINED STAFF SERVE AS PARENTS TO PROVIDE A NURTURING ENVIRONMENT FOR CHILDREN TO PRACTICE POSITIVE BEHAVIORS AND HEALTHY FAMILY RELATIONSHIPS. CHILDREN RECEIVE SPIRITUAL GUIDANCE & CHRISTIAN NURTURE THROUGH PRAYER, BIBLE STUDY, AND PARTICIPATION IN THE WORSHIP & LIFE OF LOCAL PRESBYTERIAN CHURCH (USA) CONGREGATIONS.
